ELIGIBILITY FOR CAPITAL SUBSIDY

Individuals (Residential buildings):

Bonafied consumer of TSECL

Institutions and social sector (Not for profit registered organizations):

Bonafied consumer of TSECL and Registered under Societies Registration Act, 1860 / Indian Trust Act 1882.

Requirement: Unused shadow free south facing roof approximately 10 m² per KWp.

 - **INDIVIDUALS:** Electricity bill and payment receipt of TSECL (Should not be less than three months old).
 - **INSTITUTIONS AND SOCIAL SECTOR:** Electricity bill and payment receipt of TSECL (Should not be less than three months old) and Societies Registration Certificate / Indian Trust Act 1882.
